GRANT OF TRADEMARK SECURITY INTEREST

THIS GRANT OF TRADEMARK SECURITY INTEREST, dated as of December 18, 2017, is entered into by Rodo Medical, Inc., a California corporation with a principal place of business at 6399 San Ignacio Ave., Suite 100, San Jose, CA 95119 ("Grantor"), and Institut Straumann AG ("Grantee").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the Security Interest, Grantor hereby grants to Grantee the Security Interest in all of the Debtor's right, title and interest in and to all trademark and service mark rights and like protections, whether registered or unregistered, including without limitation improvements, divisions, continuations, renewals, reissues, extensions and continuations-in-part of the same, including the trademark and service mark applications set forth on Schedule A hereto, and all foreign counterparts, together with the goodwill of the business symbolized by the foregoing and all rights to any causes of action for and claims for damages by reason of infringement of any of such trademark and service mark applications and like protections, past, present and future, wherever located and whether arising prior to or after the date hereof, and any and all other rights arising out of or otherwise relating thereto and all proceeds thereof, such as, by way of example and not by limitation, license royalties and proceeds of infringement suits (the "Trademark Collateral").

The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Grantee with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein, including, without limitation, the provisions related to termination of the Security Agreement (and the Security Interest).
