The Assignor hereby perpetually and exclusively sells, assigns, transfers and conveys to the Assignee, in consideration of the sum of one dollar (\$1) and other good and valuable consideration, the receipt of which is hereby acknowledged, the entire rights, title and interest in and to the Trademarks, together with the goodwill of the business connected with the use and as symbolized by the Trademarks, along with all common law and statutory rights related thereto, all rights of renewal and extension effective as of December 1, 2017.

The Assignor further assigns to the Assignee the right to sue for past infringement and to recover and retain all damages and profits arising in connection with such Trademarks.






CERTIFICATE OF RESOLUTION


