NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, the Parties have agreed as follows :


#### ARTICLE 1: OBJECT OF THE AGREEMENT


ASSIGNOR does hereby assign, grant, transfer and otherwise convey to ASSIGNEE, its successors and assigns, its entire right, title and interest in and to ORIENT EXPRESS, U.S. Trademark Registration No. 3,676,783, registered September 1, 2009, including but not limited to all of ASSIGNOR's common law rights and registrations pertaining thereto, as well as all of the good will of the business symbolized by said TRADEMARK, and the right to sue for past infringements thereof. Assignee further agrees that it will refrain from use or registration of the ORIENT EXPRESS mark and will not object to use of the ORIENT EXPRESS mark by ASSIGNEE for any goods or services.

#### ARTICLE 2: CONSIDERATION


