**TRADEMARK RELEASE**

THIS TRADEMARK RELEASE is made as of December 21, 2017, by TEXAS CAPITAL BANK, NATIONAL ASSOCIATION as Administrative Agent (in such capacity, “Secured Party”), for the benefit of Censeo Health, LLC (“Grantor”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below) or, if not defined therein, in the Credit Agreement or Security Agreement (as each is defined in the Trademark Security Agreement).

WHEREAS, Grantor and Secured Party are parties to that certain Trademark Security Agreement dated as of June 22, 2015 (the “Trademark Security Agreement”), pursuant to which the Grantor granted a security interest to Secured Party in the Trademark Collateral, including the Trademarks set forth on Schedule 1 hereto, as security for the Secured Obligations;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on June 24, 2015, at Reel 5559, Frame 0979; and

WHEREAS, Grantor has requested that Secured Party release its security interest in the Trademarks set forth on Schedule 1 hereto and all other Trademark Collateral, and terminates, cancels, releases, and discharges any and all rights in the same.


NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
