## RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 11, 2017 (this "Release"), is made by **PNC BANK, NATIONAL ASSOCIATION**, as agent for the Lenders (the "Agent") under that certain (i) Intellectual Property Security Agreement, dated as of August 31, 2015 by PrimeSport, Inc. ("PrimeSport"), North America Sports Media, Inc. ("NASM"), Gotickets, Inc. ("Gotickets"), and Steve's Frugal International Tennis Tours ("Tennis") in favor of Agent (as amended, supplemented, or modified and in effect from time to time, the "PrimeSport Trademark Security Agreement"), (ii) that certain Intellectual Property Security Agreement dated as of July 29, 2016 by CID Entertainment, LLC ("CID") and CID Presents LLC ("CID Presents") in favor of Agent (as amended, supplemented or modified and in effect from time to time, the "CID Trademark Security Agreement"), and (iii) Intellectual Property Security Agreement, dated as of August 19, 2016 by Curadora, LLC ("Curadora" and collectively with PrimeSport, NASM, Gotickets, Tennis, CID, and CID Presents, the "Grantors") in favor of Agent (as amended, supplemented, or modified and in effect from time to time, the "Curadora Trademark Security Agreement", and collectively with the PrimeSport Trademark Security Agreement and the CID Trademark Security Agreement, the "Trademark Security Agreements"). Capitalized terms used and not otherwise defined herein have the meanings ascribed thereto in the Trademark Security Agreements.

**WHEREAS**, pursuant to the Trademark Security Agreements, each Grantor granted to the Agent a continuing security interest in all of such Grantor's right, title and interest in and to its Trademarks, including those set forth on the attached Schedule A, and the other IP Collateral; and

**WHEREAS**, pursuant to the (i) PrimeSport Trademark Security Agreement, the security interest granted to the Agent on the Trademarks was recorded at the United States Patent and Trademark Office on September 3, 2015 at Reel/Frame 5616/0579, (ii) CID Trademark Security Agreement, the security interest to the Agent on the Trademarks was recorded in the United States Patent and Trademark Office on August 1, 2016 at Reel/Frame 5844/0666, and (iii) Curadora Trademark Security Agreement, the security interest to the Agent on the Trademarks was recorded in the United States Patent and Trademark Office on August 24, 2016 at Reel/Frame 5863/0048.



The Agent hereby authorizes the Grantors, and any of their designees, to file this Release with the United States Patent and Trademark Office to evidence the release and termination of the security interest in the Trademarks contemplated hereby.
