RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE AND TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 21, 2017 (this "Release"), is made by **PNC BANK, NATIONAL ASSOCIATION**, as agent for the Lenders (the "Agent") under that certain First Priority Trademark Security Agreement, dated as of March 13, 2017 by HHG Global Designs LLC, as grantor ("Grantor"), in favor of Agent (as amended, supplemented, or modified and in effect from time to time, the "Trademark Security Agreement"). Capitalized terms used and not otherwise defined herein have the meanings ascribed thereto in the Trademark Security Agreements.

WHEREAS, pursuant to the Trademark Security Agreements, Grantor granted to Agent a continuing security interest in all of such Grantor's right, title and interest in and to its Trademarks, including those set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, pursuant to the Trademark Security Agreement, the security interest granted to the Agent on the Trademarks was recorded at the United States Patent and Trademark Office on March 16, 2017 at Reel/Frame 6011/0660.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Trademark Security Agreement in the Trademarks, (b) release and relinquish its security interest in the Trademarks, and (c) discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademarks. The Agent hereby authorizes the Grantor, and any of their designees, to file this Release with the United States Patent and Trademark Office to evidence the release and termination of the security interest in the Trademarks contemplated hereby.

THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.
