TRADEMARK ASSIGNMENT

Further, with respect to the intent-to-use trademark Applications identified on Exhibit A, the transfer of such Applications, and as Assignee is the successor-in-interest of Assignor’s business, such transfer accompanies the transfer of Assignor’s business, or portion of the business to which the trademarks pertain and that business is ongoing and existing as of the date hereof.


By this Assignment, Assignor hereby (i) authorizes Assignee or its agents or attorneys to insert the jurisdictions, Application numbers, filing dates and any other idicia identifying the Applications when such information is available for the purpose of recording this Assignment; and (ii) authorize the United States Patent and Trademark Office or any equivalent authority to issue to Assignee each and every trademark, registration and other form of protection, right and title granted upon the Applications.

This Assignment shall inure to the benefit of Assignee and its successors and assigns, and shall be binding upon Assignor and its successors and permitted assigns. Delivery of this Assignment by copy, however transmitted, constitutes valid and effective delivery. This Assignment may be executed in one or more counterparts, each of which when so executed and


