TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of December 15, 2017 (“Release”), is made by Regions Bank, as Collateral Agent (“Collateral Agent”), in favor of Sterling Operations, Inc., a Delaware corporation (“Obligor”).

WHEREAS, pursuant to that certain Security Agreement dated as of August 14, 2015 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Obligor, Collateral Agent, and others party thereto and the Notice of Grant of Security Interest in Trademarks (“Trademark Notice”) by and among the Obligor and Collateral Agent, Obligor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a continuing security interest and continuing lien upon, and a right to set off against, the Trademarks, including the trademarks set forth on Schedule A, and any and all right, title and interest of Obligor in and to the Trademarks (collectively, the “Trademark Collateral”); and

WHEREAS, the Trademark Notice was recorded at the United States Patent and Trademark Office (“USPTO”) on August 17, 2015 at Reel 5600 Frame 0824.

NOW THEREFORE, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Collateral Agent, on behalf of the Secured Parties, and Obligor agree as follows:

SECTION 1. Defined Terms. Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Notice.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Secured Parties, hereby:

(a) terminates the Trademark Notice;

(b) terminates, cancels, forever discharges, and releases the continuing security interest and continuing lien upon, and right to set off against, the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto;

(c) represents and warrants that it has full authority to execute and deliver this Release; and

(d) authorizes the recordation of this Release with the USPTO at Obligor’s expense.

SECTION 3. Further Assurances. Collateral Agent, at Obligor’s expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Collateral Agent will, at Obligor’s expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
