2. Assignor shall execute and deliver, without consideration, such documents as Assignee may reasonably request, and take any and all other actions necessary, proper or advisable to more effectively convey, transfer and assign to Assignee (or to more effectively record or evidence the same) the Assigned Mark, including any documents necessary to withdraw the Opposition.

3. Assignor hereby authorizes and requests that the United States Patent and Trademark Office record this Assignment.

4. This Assignment shall be governed by, and construed in accordance with, the laws of the State of Illinois applicable to contracts executed in and to be performed entirely within that state, and the U.S. laws applicable to trademark assignments.


