RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of December 22, 2017 (this "Release"), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as administrative agent (in such capacity, the "Agent"), in favor of MOUNT AIRY #1, L.L.C. ("Grantor"). Capitalized terms used but not otherwise defined herein shall have the meaning set forth in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, the Grantor and the Agent entered into that certain First Lien Trademark Security Agreement, dated as of August 28, 2015 (the "Security Agreement"), pursuant to which the Grantor granted to the Agent a security interest in and to all of their right, title and interest in, to and under the Trademark Collateral owned by Grantors including, without limitation, the trademark registrations and applications listed on Schedule A attached hereto;

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 28, 2015 at Reel 5611 and Frame 0267; and

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in and to the Trademark Collateral.

NOW, THEREFORE, in consideration of the premises, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interests created under the Security Agreement in the Trademark Collateral, (b) discharge and release its security interest in and to the Trademark Collateral, and (c) reassign any and all rights, title and interest it has in the Trademark Collateral to the Grantor.

THIS RELEASE SHALL BE DEEMED TO BE A CONTRACT UNDER THE LAW OF THE STATE OF NEW YORK WITHOUT REGARD TO ITS CONFLICT OF LAWS PRINCIPLES THAT WOULD REQUIRE THE APPLICATION OF ANY OTHER LAW.


