## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is made as of December 22, 2017 in favor of Xcellence Holdings LLC, a Delaware limited liability company ("Holdings"), Xcellence, Inc., a Missouri corporation (and successor by merger to MMP, LLC, a Kansas limited liability company, and XDD California, LLC, a Kansas limited liability company) (the "Company"), F1 Discovery, LLC, a California limited liability company ("F1"), Orange Audit Services, LLC, a Kansas limited liability company ("OAS"), The Litigation Document Group LLC, a Utah limited liability company ("LDG"), Orange Document Services, LLC, a Utah limited liability company ("ODS"), and XDD MN, LLC, a Minnesota limited liability company ("XDD MN"; Holdings, the Company, F1, OAS, LDG, ODS and XCC MN are referred to herein, collectively, as "Grantors" and, individually, as a "Grantor"), by TCF National Bank, individually ("TCF"), and in its capacity as administrative agent (in such capacity, the "Administrative Agent") for the lenders from time to time party to the Credit Agreement referred to in the 2016 Security Agreement (as defined below).

WHEREAS, pursuant to the terms and conditions of (a) that certain Patent, Copyright, License and Trademark Security Agreement, dated as of November 30, 2016 (the "2016 Security Agreement"), executed by Grantors (other than XDD MN) in favor of the Administrative Agent, each Grantor (other than XDD MN) granted to the Administrative Agent a security interest in all of such Grantor's right, title and interest in and to its intellectual property, including, but not limited to, the trademark applications and registrations set forth on Schedule 1 attached hereto (collectively the "Intellectual Property Collateral"), and (b) that certain Patent, Copyright, License and Trademark Security Agreement, dated as of January 6, 2015 (the "2015 Security Agreement"; collectively, the "Security Agreements" and, individually, a "Security Agreement"), executed by Holdings, the Company and XDD MN and in favor of TCF, each of Holdings, the Company and XDD MN granted to TCF a security interest in all of such Grantor's right, title and interest in and to certain of the Intellectual Property Collateral;

WHEREAS, the 2016 Security Agreement was recorded with the United States Patent and Trademark Office on December 1, 2016 at Reel/Frame 5931/0619 and the 2015 Security Agreement was recorded with the United States Patent and Trademark Office on January 16, 2015 at Reel/Frame 5442/0741.

WHEREAS, each of TCF and the Administrative Agent wishes to release its security interest in the Intellectual Property Collateral and reassign to each Grantor all of TCF's and the Administrative Agent's right, title and interest in and to the Intellectual Property Collateral of such Grantor.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each of TCF and the Administrative Agent hereby terminates the 2015 Security Agreement and the 2016 Security Agreement, respectively, and hereby terminates, cancels and releases any security interest it may have in the Intellectual Property Collateral and reassigns to each Grantor any rights it may have in the Intellectual Property Collateral.

TCF and the Administrative Agent shall take all further actions, and provide to Grantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release. Each Grantor is hereby authorized to file and record this Release with the appropriate governmental agency or authority as evidence of the release of security interest granted hereunder.
