RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST (this "Release") effective as of December 19, 2017 (the "Effective Date"), is made by Capital One Business Credit Corp. (f/k/a Capital One Leverage Finance Corp.), a Delaware Corporation ("Lender"), in favor of Hanover Direct, Inc., a Delaware corporation ("Hanover"), and certain borrowing subsidiaries from time to time party hereto (together with Hanover, collectively the "Borrowers" or each, a "Borrower"). All capitalized terms used but not otherwise defined herein shall have the meanings ascribed to those terms in that certain *Loan & Security Agreement (the "Loan Agreement")* dated as of December 22, 2011 between the parties.

WITNESSETH:

WHEREAS, pursuant to the Loan Agreement, the Borrowers granted a security interest to Lender against Borrowers' Intellectual Property (as Intellectual Property is defined in the *Loan Agreement*);

WHEREAS, in accordance with the Loan Agreement, the Lender and Borrowers executed the following short-form security agreements for the purpose of recording the security interests in favor of the Lender at the USPTO:

* *Trademark Security Agreement*, dated as of December 22, 2011, which was recorded in the USPTO on January 5, 2012 at Reel/Frame 4693/0035; Reel/Frame 4693/0183; Reel/Frame 4693/0105; Reel/Frame 4693/0147; Reel/Frame 4693/0116; and Reel/Frame 4693/0048 against the trademark applications and registrations set forth on Exhibit A; and

* *Copyright Security Agreement*, dated as of December 22, 2011, including, but not limited to, those copyright registrations set forth on *Exhibit B*.

WHEREAS, all Obligations of the Borrowers under the *Loan Agreement* have been satisfied and thus the Borrowers are entitled to a release of the Lender's security interest in all Intellectual Property and Lender wishes to release its security interest in all of Borrower's Intellectual Property;

WHEREAS, Lender wishes to provide a document to Borrowers suitable for recording the release of the security interest at the USPTO and other possible government agencies to evidence the release of any Liens against Borrowers' Intellectual Property.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereto agree as follows:

1. Release. The Lender hereby irrevocably releases, cancels, relinquishes and discharges the security interest and any Liens that the Borrowers granted to Lender pursuant to the *Loan Agreement* and related *Trademark Security Agreement* and *Copyright Security Agreement* in Borrowers' Intellectual Property, in each case, without recourse to or warranty by the Lender, including, but not limited to, those trademark and copyrights set forth on *Exhibit A* and *Exhibit B*.
2. Further Assurances. The Lender agrees to the execute and deliver (at Borrowers' sole cost and expense) any additional documents or other instruments reasonably requested by the Borrowers and delivered to the Lender to effect this release of the security interest and Liens in Borrowers' Intellectual Property or to evidence the release and termination of the Lender's security interest and Liens in Borrowers' Intellectual Property pursuant to this Release.
3. Governing Law. This Release and the rights and obligations of the parties hereunder shall be governed by, and shall be construed and enforced in accordance with, the laws of the State of New York without regard to conflict of laws principles thereof that would result in the application of any law other than the law of the State of New York.
4. Counterparts. This Agreement may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. No provision of this Release is intended to confer upon any person other than the parties hereto any rights or remedies hereunder.
