
1. I am the Chief Executive Officer for Watkins Incorporated and have knowledge of the matters certified hereto.
2. A notice of security interest dated March 25, 2003 between Watkins Incorporated, a Delaware Corporation, with a place of business at 150 Liberty Street, Winona, MN 55987, and Marshall Bank, N.A. as agent for itself and Winona National Bank, with a place of business at 150 S. Fifth Street Suite 2910, Minneapolis, MN 55402, was recorded at Trademark Reel 002705 Frame 725-728 at the United States Patent & Trademark Office against the trademarks listed on Annex 1 attached hereto.
3. The underlying loan was paid in full. The UCC security interest in the trademarks was released on August 29, 2007, in Delaware, and expired on March 27, 2008 in Minnesota. Attached hereto is a copy of the Delaware termination of security interest with expiration date of March 27, 2008.
4. Marshall Bank, N.A. is now defunct and therefore Watkins Incorporated is filing this notice directly.
