TRADEMARK SECURITY AGREEMENT RELEASE

This TRADEMARK SECURITY AGREEMENT RELEASE (this “**Release**”), dated as of December 19, 2017, is made by Wells Fargo Bank, National Association, as administrative agent (in such capacity, the “**Agent**”) for the Secured Creditors in favor of Fortegra Financial Corporation, a Delaware corporation (“**Fortegra**”), LOTSolutions, Inc., a Georgia corporation (“**LOT**”), Pacific Benefits Group Northwest, L.L.C., an Oregon limited liability company (“**Pacific**”) and 4Warranty Corporation, a Florida corporation (“**4Warranty**,” and together with Fortegra, LOT and Pacific collectively referred to as the “**Grantors**”). All capitalized terms used herein without definition are used as defined in the Credit Agreement and the Security Agreement referenced below.

WHEREAS, pursuant to that certain Credit Agreement, dated as of August 2, 2012 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time prior to the date hereof, the “**Credit Agreement**”) among Fortegra and LOTS Intermediate Co., a Delaware corporation, as Borrowers, the lenders party thereto and Agent, the Grantors and the other Credit Parties executed and delivered that certain Amended and Restated Security Agreement (as the same may be amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”, dated as of December 4, 2014 in favor of the Agent; and

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered that certain Trademark Security Agreement, dated as of December 4, 2014 (as amended, restated, amended and restated, supplemented and/or otherwise modified from time to time, the “**Trademark Security Agreement**”) in favor of the Agent, pursuant to which the Grantors mortgaged, pledged and hypothecated to Agent for the benefit of the Secured Creditors and granted to the Agent for the benefit of the Secured Creditors a lien on and security interest in, among other collateral as set forth therein, all of its right, title and interest in, to and under all of its Trademark Collateral, including without limitation such Trademark Collateral set forth on Schedule A hereto.

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 4, 2014 at Reel 005414 and Frame 0020; and

WHEREAS, the Agent wishes to terminate and release its lien on and security interest in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

**SECTION 1. Release of Grant of Security.** The Agent, for itself and on behalf of the Secured Creditors, hereby (a) terminates the Trademark Security Agreement, and (b) terminates, cancels, relinquishes, discharges and releases to the Grantors its lien on and security interest in, to and under, and reassigns to the Grantors, without representation or warranty of any kind, any and all right, title and interest in, to and under the Trademark Collateral, including, without limitation, the Trademark Collateral listed on Schedule A, granted to it pursuant to the Trademark Security Agreement, and all goodwill of the business connected with the use of, and symbolized by, each trademark and trademark application set forth on Schedule A.

The Agent hereby agrees to duly execute and deliver any further documents and do such other acts as may be reasonably necessary to effect the termination, cancellation, release, relinquishment and discharge of its continuing security interest in, to and under all of the intellectual property contemplated hereby.

SECTION 2. Recordation. The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 3. Execution in Counterparts. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

SECTION 4. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
