## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Termination and Release of Trademark Security Agreement (the “Termination and Release”), dated as of December 20, 2017, is made by ALLY BANK, as agent (in such capacity, “Agent”) for the Lenders under the Trademark Security Agreement (as defined below), in favor of LEEHAR DISTRIBUTORS, LLC (the “Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 1, 2016, by and between Grantor and Agent for the Lenders (the “Trademark Security Agreement”), recorded with the United States Patent and Trademark Office on November 10, 2016 at Reel 5938 / Frame 0273, Grantor granted to the Agent a security interest in certain Trademark Collateral of the Grantor, including, without limitation, the trademarks and trademark registrations listed on Schedule A attached hereto;


WHEREAS, the Agent has agreed to execute this Termination and Release to evidence the termination and release its security interest in the Trademark Collateral, as herein provided. Capitalized terms used herein without definition are used as defined in the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and other value received, Agent on behalf of Agent and Lenders hereby releases, terminates and discharges its Lien on and security interest in all of its right, title, and interest in and to the Trademark Collateral, including, without limitation, the trademarks and trademark registrations listed on Schedule A attached hereto, and hereby reassigns to Grantor any and all right, title, and interest that the Agent may have in or to such Trademark Collateral. Agent agrees to execute and deliver such further instruments and take or cause to be taken such other or further action as Grantor and its successors, assigns or other legal representatives may reasonably request in order to perfect, confirm or evidence such release. The Agent hereby authorizes and requests that the Commissioner for Trademarks of the United States Patent and Trademark Office record this Termination and Release. This Termination and Release shall be construed, interpreted and the rights of the parties determined in accordance with the laws of the State of New York.


