1. They are the President and the Secretary, respectively, of TELEPAYROLL.COM, INC., a California corporation, with California Secretary of State entity number C0964990 (the "Corporation").
2. Article 1 to the Articles of Incorporation of this Corporation, which was previously amended and filed March 22, 1999 with the California Secretary of State, is amended and restated to read in its entirety as follows:

"The name of this corporation is TELEPAYROLL, INC."

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the board of directors.
4. The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding shares of the corporation is 7,500,000. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
