- 4. Further Assurances. Assignor further covenants that, when requested, it will, without charge to Assignee, execute and deliver all documents and take all such further actions as may be necessary, desirable, or convenient to enable Assignee to obtain, maintain, and enforce its rights and interest in and to the Trademark and all other rights assigned hereunder and to perfect in Assignee sole and exclusive title to the Trademark and the other rights transferred hereunder anywhere in the world. In furtherance of the foregoing sentence, Assignor hereby appoints Assignee as its attorney in fact to execute and deliver any and all such documents as Assignee may deem necessary or appropriate to vest in Assignee sole and exclusive right, title, and interest in and to the Trademark and all other rights assigned hereunder. Such appointment shall be deemed to be a power coupled with an interest and is, therefore, irrevocable.
- 5. **Communication**. Assignee is authorized to communicate with the United States Patent and Trademark Office (and corresponding office or agencies in individual states of the United States or in other countries of the world), and the United States Patent and Trademark Office (and corresponding office or agencies in individual states of the United States or in other countries of the world) is authorized to receive and act upon all instructions, communications, correspondence, or other information sent or provided by Assignee to the same extent as if this Assignment had not been made and such item had been received from Assignor.
