WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, all of the Assignor's rights, title and interest in and to the OFFICIAL BURGER OF TAMPA BAY service mark, including, without limitation, U.S. Trademark Registration No. 4,122,307 for said mark, all common law and other rights, the benefit of prior use thereof and the goodwill of the business associated therewith and symbolized thereby (collectively, the "Mark").

NOW, THEREFORE, for Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Mark, including without limitation, U.S. Trademark Registration No. 4,122,307, all common law rights, the benefit of Assignor's prior use of the Mark, the associated goodwill, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign jurisdiction, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, at least as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

This Assignment shall be governed by and construed in accordance with the domestic laws of the State of Florida without giving effect to any choice or conflicts of laws provision or rule (whether of the State of Florida or any other jurisdiction) that would cause the application of the laws of any other jurisdiction.


