GRANT OF SECURITY INTEREST IN TRADEMARKS

December 29, 2017

WHEREAS, each of LDC Stone, Inc., a Delaware corporation ("**Holdings**"), Marva II, LLC, a Delaware limited liability company ("**Marva**") and Republic Elite, LLC, a Texas limited liability company ("**Republic Elite**"; Holdings, Marva and Republic Elite are referred to herein collectively as the "**Grantors**" and each individually as a "**Grantor**"), owns the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith, in each case as set forth on Schedule A attached hereto (the "**Marks**"); and

WHEREAS, MB Financial Bank, N.A. (the "**Grantee**"), desires to acquire a security interest in, and lien on, all of each Grantor's right, title and interest in and to the Marks; and

WHEREAS, each Grantor is willing to grant to the Grantee a security interest in and lien upon the Marks as described below.

NOW, THEREFORE, for good and valuable consideration, the sufficiency and receipt of which are hereby acknowledged, and subject to the terms and conditions of the Credit and Security Agreement, dated as of the date hereof, between the Grantors and the other Persons party thereto as "Borrowers" and the Grantee (as amended, restated, modified or supplemented from time to time, the "**Credit Agreement**"), each Grantor hereby grants to the Grantee a security interest in, and a lien upon, all of such Grantor's right, title and interest in and to (i) the Marks, (ii) all Proceeds (as such term is defined in the Credit Agreement) of the Marks, and (iii) all causes of action, past, present and future, for infringement, misappropriation, or dilution of any of the Marks or unfair competition regarding the same.

This GRANT OF SECURITY INTEREST is made to secure the satisfactory performance and payment of all the Obligations (as such term is defined in the Credit Agreement) and shall be effective as of the date of the Credit Agreement.

The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Credit Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant of Security Interest are deemed to conflict with the Credit Agreement, the provisions of the Credit Agreement shall govern.
