DEED OF ASSIGNMENT

This Deed of Assignment made the 14th day of June Two Thousand Seventeen

BETWEEN

Koninklijke Philips N.V., a public limited liability company incorporated in the Netherlands, with corporate seat in Eindhoven, the Netherlands and registered address at High Tech Campus 5, 5656 AE Eindhoven, the Netherlands, (hereinafter “**Assignor**”) of the one part

and

Lumileds LLC, a limited liability company incorporated in the State of Delaware with a registered address at 370 West Trimble Road, San Jose, California 95131 (hereinafter “**Assignee**”) of the other part,

This Deed of Assignment is to confirm the following:

Assignor is the registered owner of the Trademarks as listed in Annex A (“the Trademarks”);

In consideration of a sum of € 1.00 (one Euro), the receipt and sufficiency of which is hereby acknowledged and effective as of the date first written above, Assignor hereby conveys, transfers, assigns, delivers, and contributes to Assignee all of Assignor's right, title, and interest of whatever kind in and to the Trademarks in all jurisdictions (including, without limitation, the right to renew any registrations included in the Trademarks, the right to apply for trademark registrations anywhere worldwide based in whole or in part upon the Trademarks, and any priority right that may arise from the Trademarks), together with

- (1) the goodwill of the business relating to the products/services in respect upon which the Trademarks are used and/or for which they are registered,
- (2) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademarks, including but without limitation, damages and payments for past or future infringements and misappropriations of the Trademarks and
- (3) all rights to sue for past, present and future infringements or misappropriations of the Trademarks,

the same to be held and enjoyed by Assignee as fully and entirely as said interest could have been held and enjoyed by Assignor had this sale, assignment, transfer and conveyance not been made;

and Assignee has accepted said assignment.

Assignor hereby grants full power of attorney to Assignee, including the right of substitution to its affiliates and agents, to submit this Deed of Assignment, including Annex A, to the competent authorities of the countries and territories in which the Trademarks are registered or are in a pending application process, and to request those authorities to record the assignment of the legal title to the Trademarks from Assignor to Assignee in the appropriate registers.

Assignor agrees to further execute any documents reasonably necessary to effect this assignment or to confirm Assignee's ownership of the Trademarks.
