## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release"), dated as of December 29, 2017, is made by and among The Thomas B. Semans, III Trust, Under Trust Agreement Dated March 31, 1992, As Amended and Restated October 4<sup>th</sup>, 1996, whose address is 10002 Asheboro Street, Frisco, Texas 75035 (hereinafter referred to as the "Semans Trust") in favor of Flavor Delite, Inc., a Florida corporation having its principal place of business at 752 Harbour Isles Way, Palm Beach Gardens, Florida 33410, as successor in interest to Flavor Delite, Inc., a dissolved New Jersey corporation (hereinafter referred to as "Flavor Delite"), as follows:

### WITNESSETH

WHEREAS, pursuant to the **TRADEMARK SECURITY AGREEMENT**, dated as of July 23<sup>rd</sup>, 2015 (the "Security Agreement"), and recorded with the U.S. Patent and Trademark Office on August 7<sup>th</sup>, 2015 at Reel/Frame No. 005595/0342, Flavor Delite granted the Semans Trust a Lien on and continuing security interest in, all of its right, title and interest in, to and under the "Collateral" (as defined therein) pledged by Flavor Delite as described therein, including, without limitation, the United States Trademarks & Registrations set forth in Exhibit A attached thereto (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks;

WHEREAS, the Semans Trust acknowledges payment in full of Flavor Delite's "Obligations" to the Semans Trust, as defined in the Security Agreement; and

WHEREAS, Flavor Delite has requested that the Semans Trust release its Lien on and continuing security interest in, all right, title and interest of the Semans Trust in and to the Collateral.

NOW, THEREFORE, in consideration of the forgoing, the Semans Trust, hereby:

1. releases and reassigns to Flavor Delite any and all liens, security interests, right, title and interest of the Semans Trust pursuant to the Security Agreement in the Collateral, including the Trademarks more fully described in Exhibit A as re-printed and attached hereto, without recourse or representation or warranty, express or implied; and
2. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the release hereby given.
