**ARTICLES OF ORGANIZATION  
OF  
FUNKY BUDDHA BREWERY LLC**

The undersigned, being a duly authorized representative of the Member, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is Funky Buddha Brewery LLC (the "Company").

**ARTICLE II  
ADDRESS**

The principal and mailing address of the Company is: 1201 NE 38TH ST., OAKLAND PARK, FL 33334.

**ARTICLE III  
REGISTERED AGENT AND OFFICE**

**ARTICLE VII  
PURPOSE**
