RELEASE OF TRADEMARK SECURITY INTEREST

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “*Release*”) is made effective as of December 29, 2017 (the “*Effective Date*”), by and from High Roller Capital LLC, a Texas limited liability company (“*Secured Party*”), to Marolina Outdoor Inc., a Delaware corporation (“*Grantor*”).

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. Release of Security Interest. Secured Party hereby releases, terminates, cancels, relinquishes and discharges any security interest it may have in, and any right of set off against, the Trademarks and the other Trademark Collateral (as defined in the Security Agreement) and retransfers and reassigns any and all right, title and interest it may have in and to the foregoing without recourse to Grantor.
3. Delivery by Facsimile. Delivery of an executed signature page to this Release by facsimile or electronic (including .pdf file) transmission shall be as effective as delivery of a signed counterpart of this Release.
