
accrued, arising out of past infringements of the Trademarks, and the right to sue and recover for same.



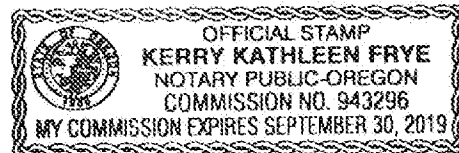

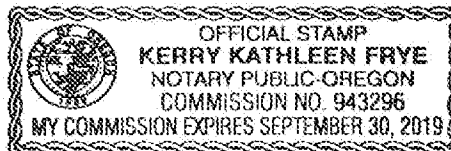
