TRADEMARK AND DOMAIN NAME ASSIGNMENT

(a) all rights and obligations under any license agreements governing use of the Trademarks and Domain Names;

(b) all rights and obligations in and to all of the goodwill of the business associated with the Trademarks and Domain Names and the ongoing and existing business of the Assignor to which the Trademarks and Domain Names pertain; and

(c) all claims for damages by reason of past or current infringement of same, with the right to sue for and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

Registration of Domain Names. Assignor will make all necessary arrangements to ensure that the appropriate registrar(s), or any other registrar(s) handling the registration of the Domain Names, transfers the Domain Names to Assignee in a timely manner following execution of this Assignment. Assignor hereby requests the relevant registrar(s) and any other appropriate domain name registration authorities that exercise authority over the Domain Names, to transfer the Domain Names to Assignee. Upon execution of this Assignment, Assignor shall unlock the Domain Names, provide

Assignee with the authorization code for the transfer, and approve the transfer request for the Domain Names.

This Assignment shall be binding upon and shall inure to the benefit of the respective successors and assigns of Assignor and Assignee.

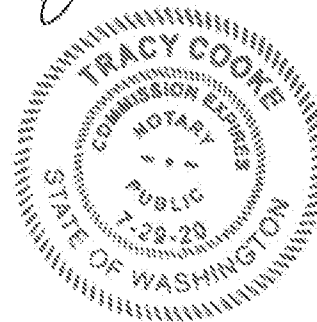

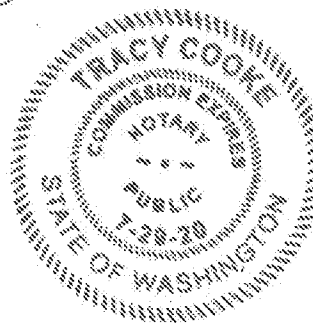
