**NOTICE AND CONFIRMATION OF GRANT OF
SECURITY INTEREST IN TRADEMARKS**

THIS NOTICE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (“Agreement”), dated as of January 1, 2018, is made by each of the undersigned (each a “Granting Party” and collectively, the “Granting Parties”), in favor of Bank of America, N.A. (the “Agent”), as administrative agent for the several banks and other financial institutions (the “Lenders”), parties to the Third Amended and Restated Credit Agreement, dated as of January 1, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Credit Agreement”), among Graphic Packaging International, LLC, a Delaware limited liability company (the “Company”), certain Subsidiaries of the Company from time to time party thereto (together with the Company, the “Borrowers”), the Agent, and the Lenders from time to time party thereto.

W I T N E S S E T H:

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make loans and other extensions of credit to the Borrowers upon the terms and conditions set forth therein;

WHEREAS, in connection with the Credit Agreement, Graphic Packaging International Partners, LLC, the Company and certain of its Subsidiaries executed and delivered a Third Amended and Restated Guarantee and Collateral Agreement, dated as of January 1, 2018, in favor of the Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the “Guarantee and Collateral Agreement”);

WHEREAS, pursuant to the Guarantee and Collateral Agreement, each Granting Party has granted to the Agent a security interest in its Intellectual Property, including the Trademarks and Trademark Applications set forth on Exhibit A attached hereto; and

WHEREAS, each Granting Party has duly authorized the execution, delivery and performance of this Agreement;

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and in order to induce the Lenders to continue and to make Loans and other financial accommodations to the Borrowers pursuant to the Credit Agreement, the Granting Parties agree, for the benefit of the Agent, as follows:

SECTION 1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement, including its preamble and recitals, have the meanings provided or provided by reference in the Credit Agreement and the Guarantee and Collateral Agreement.

SECTION 2. Grant of Security Interest. Each Granting Party hereby confirms that pursuant to the Guarantee and Collateral Agreement, subject to existing licenses to use the Trademarks granted by each Granting Party in the ordinary course of its business, it granted to the

Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Trademarks of such Granting Party (including, without limitation, those items listed on Schedule A hereto) and to the extent not otherwise included, all Proceeds and products of any and all of the Trademarks, as collateral security for the prompt and complete payment and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations, except that no security interest is or will be granted pursuant hereto in any right, title or interest of such Granting Party under or in any Trademarks or Trademark Licenses with Persons other than a Subsidiary of the Company for so long as, and to the extent that, the granting of such a security interest pursuant thereto would result in a breach, default or termination of such Trademarks or Trademark Licenses.

SECTION 3. Purpose. This Agreement has been executed and delivered by the Granting Parties for the purpose of recording the security interest granted pursuant to the Guarantee and Collateral Agreement with the United States Patent and Trademark Office. This Agreement is expressly subject to the terms and conditions of the Guarantee and Collateral Agreement. The Guarantee and Collateral Agreement (and all rights and remedies of the Secured Parties thereunder) shall remain in full force and effect in accordance with its terms.




