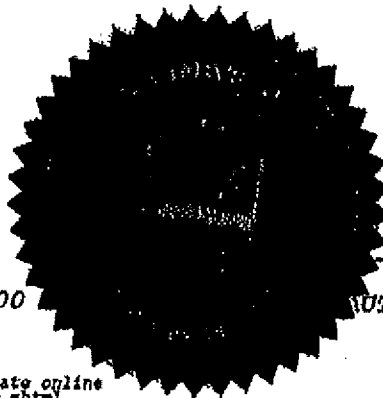

"FIRST: The name of the Corporation is Adralto Industries, Inc."

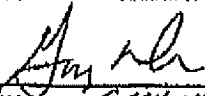
