## RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated January 5, 2018, is made in favor of **FACTORTRUST, INC** (“Debtor”), by **SILICON VALLEY BANK** (“Secured Party”). Secured Party agrees, at the Debtor’s expense, to take all further actions, and provide to the Debtor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Debtor and its successors, assigns and legal representatives may reasonably request in order to confirm, effectuate or record this Release of Trademark Security Agreement.
