RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of January 4, 2018, is executed by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking institution, in its capacity as agent for each member of the Lender Group and the Bank Product Providers (in such capacity, "Agent"), in favor of ENVIANCE, INC., a Delaware corporation (as successor by merger to Remedy Interactive, Inc., a Delaware corporation) ("Grantor"). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Trademark Security Agreement (as defined below).

RECITALS

A. WHEREAS, Grantor has, pursuant to that certain Trademark Security Agreement dated April 27, 2015, recorded on April 28, 2015 in the United States Patent and Trademark Office (the "USPTO") at Reel 5505, Frame 0026 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the "Trademark Security Agreement") granted to Agent (for the benefit of itself and each member of the Lender Group and the Bank Product Providers) a Security Interest in and to all of Grantor's right, title and interest in and to the Trademark Collateral, including without limitation those trademarks listed on Exhibit A attached hereto (collectively, the "Released Collateral"); and

B. WHEREAS, Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and each member of the Lender Group and the Bank Product Providers, hereby terminates and releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Trademark Security Agreement. Agent acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Grantor. The Agent authorizes the Grantor and its respective designees to record this Release with the USPTO and other applicable registry at the sole expense of the Grantor and agrees to provide the Grantor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.
