DECLARATION OF MAX J. SPRECHER

I, Max J. Sprecher, declare as follows:

1. I am an attorney at law duly licensed to practice before all of the courts in the State of California and counsel of record for Awareness Technologies, Inc. ("ATI"). I have personal knowledge of the facts set forth in this Declaration and, if called as a witness, could and would testify competently to such facts under oath.

2. I provide this declaration for the purpose of correcting the state of incorporation for the registered mark "Interguard", Serial No. 3772668. As issue relates to a correction, there is no assignment documentation – only my explanation.


3. I have represented ATI since 2006 and have acted on its behalf for more than a decade in filing, obtaining, and maintaining no less than 8 U.S. trademark registrations for my client.

4. At the present time, I am reviewing ATI's files for the purpose of filing maintenance and renewal documentation as appropriate. During my review, I discovered an error I made in 2009 in connection with the application for (and eventual) registration of the mark "Interguard", Serial No. 3772668.

5. I personally filed the original application for the mark "Interguard" in 2008 on behalf of ATI on September 25, 2008. In identifying the state of incorporation, I inadvertently selected the District of Columbia in the pull down menu instead of Delaware. This was an error on my part as ATI was not (and has never been) incorporated in the District of Columbia. Unfortunately, the two states are listed sequentially and I simply did not notice my error at the time I filed the application or during any prior review.

I declare under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
