Capitalized terms used but not defined herein will have the meaning ascribed to such terms in the Trademark Security Agreement and/or the Security Agreement, as applicable.

The undersigned each hereby agree that (i) this Trademark Security Agreement Supplement may be attached to the above-referenced Trademark Security Agreement and will become and be a part thereof with the same force and effect as if originally attached thereto, and (ii) the additional Trademarks (as defined in the Trademark Security Agreement) listed on **Schedule I** to this Trademark Security Agreement Supplement will be and become part of the Collateral pledged by the undersigned to the Administrative Agent, for the benefit of the Secured Parties, in the Trademark Security Agreement (and in the Security Agreement) with the same force and effect as if originally named therein.


