**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

This TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this "Termination and Release") dated as of January 4, 2018, is made from CIT BANK, N.A. (formerly known as OneWest Bank N.A.), as administrative agent for the Lenders (in such capacity, the "Agent") to PHYSICIANS CARE ALLIANCE, LLC, an Arizona limited liability company (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the Credit Agreement (as defined in the Security Agreement referenced below), the Security Agreement (defined below) or the Trademark Security Agreement (defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Security Agreement dated as of September 18, 2014, (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), between the Grantor, PCA Skin Holdings LLC, a Delaware limited liability company, and the Agent, the Grantor executed that certain Trademark Security Agreement, dated as of September 18, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office at Trademark Reel 5365 Frame 0515, pursuant to which the Grantor granted a security interest to the Agent, for the benefit of the Lenders, in the Trademark Collateral, including certain trademarks and/or trademark applications listed on Schedule I hereto and made a part hereof.

WHEREAS, the Agent now desires to terminate and release its security interest in the Trademark Collateral and reassign any and all rights, title, and interest in the same to Grantor;


NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:
