**RELEASE OF SECURITY  
INTEREST IN TRADEMARK**


WHEREAS, pursuant to that certain Security Agreement, dated as of December 10, 1990, (the "Security Agreement") by BANK OF AMERICA, N.A. (successor to CONTINENTAL BANK, N.A.), as Collateral Agent ("Releasor"), and KASCO CORPORATION, a Delaware corporation, ("Releasee"), granted to Releasor, as Collateral Agent, a continuing security interest in and a continuing lien upon Releasee's U.S. Trademark Registration No. 1479339 for the mark KASCO ("Trademark"), which was recorded in the United States Patent and Trademark Office at Reel 0754, Frame 0832 on December 11, 1990;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Releasor hereby, without any representation and warrant and without any recourse to Releasor, releases, relinquishes and discharges its continuing security interest in and continuing lien upon the Trademark, and assigns and transfers to Releasee all of Releasor's rights in and to the Trademark.
