This Assignment includes all rights to obtain registrations and/or renewals of registration or other legal protections pertaining to the Trademarks.

Assignee, its successors and assigns, shall hold the rights to the foregoing for and during the existence of such Trademarks, and all renewals thereof, as fully and as entirely as the same would have been held and enjoyed by the assigning party had this Assignment not been made.



1. KUSH	U.S. Trademark Registration no. 3,177,919 for “alcoholic beverages, namely, liquors, distilled spirits, herb liqueurs” along with all common law rights for the registered goods and other alcoholic beverage products.
2. KUSH	U.S. Trademark Registration no. 3,785,425 for “coffee and coffee beans” along with all common law rights for the registered goods and other coffee products.
3. KUSH	U.S. Trademark Registration no. 4,462,882 for “Dried fruit and candied nuts” and “candy, candy mints, chocolate, chocolate covered nuts, chewing gums, candy bars, cinnamon rolls, cookies, fudge, gummy candies, peanut brittle, and peppermint candy” along with all common law rights for the registered goods and other fruit, candy, and nut products.
