ASSIGNMENT OF INTELLECTUAL PROPERTY

Southwest Eye Institute, Inc., an Oklahoma corporation d/b/a ClearSight Lasik ("SEI") and Dr. Gary Waine Wilson ("Wilson" and together with SEI, collectively, "Seller"), in consideration of \$10.00 and other good and valuable consideration, the sufficiency and receipt of which Seller hereby acknowledges, and pursuant to that certain Asset Purchase Agreement dated effective January 2, 2018, by and among the parties named therein (the "APA") to which this Assignment of Intellectual Property is wholly subject, has sold and does hereby assign, transfer and convey to RLR Vision, PLLC, an Oklahoma professional limited liability company ("Buyer"), its successors and assigns, all of the Purchased IP as such term is defined in the APA. All capitalized terms not otherwise defined herein shall have the same meaning as in the APA.

Seller hereby represents and warrants that Seller has good title to the Purchased IP, free and clear of all Encumbrances. This assignment, transfer and conveyance is made pursuant to the terms and conditions and is subject to the representations and warranties contained in the APA, and is effective as of the date hereof.

Without limiting the preceding, SEI hereby irrevocably assigns, grants, and transfers to RLR Vision, PLLC, all of SEI's right title and interest in and to the registered trademarks (the "Trademarks") and other Purchased IP described on **Schedule 1** attached hereto, including all common law rights and any trademark registrations and applications, along with the goodwill of the Medical Practice symbolized by use of the Trademarks, the same to be held and enjoyed by RLR Vision, PLLC, for its own use and enjoyment and the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by SEI if this assignment had not been made. RLR Vision, PLLC, further accepts the conveyance, assignment, and transfer of the Trademarks and the goodwill associated with them, and assumes SEI's obligations first arising from and after Closing under the contracts listed on **Schedule 2**.

Seller hereby covenants and agrees with Buyer, its successors and assigns, that from time to time after the delivery of this instrument, at Buyer's request and without further consideration, Seller will defend the sale, conveyance, transfer, assignment and delivery of the Trademarks and Purchased IP and will execute and deliver to Buyer such other and further instruments of transfer, assignment and conveyance and all such notices, releases, acquittances and other documents and will do or cause to be done all and every such further act as may be necessary to transfer, assign and convey to and vest in Buyer all and singular the Trademarks and Purchased IP hereby sold conveyed, transferred, assigned and delivered to Buyer or intended so to be.

The parties may execute this Assignment of Intellectual Property in counterparts, each of which shall constitute an original and all of which, when taken together, shall constitute one and the same instrument.
