Pursuant to Title 8, Section 252 of the General Corporation Law of the State of Delaware (the "DGCL"), the undersigned corporation, Sterling Infosystems, Inc. (the "Corporation"), hereby certifies the following information relating to the merger (the "Merger") of EmployeeScreenIQ, Inc., an Ohio corporation ("EmployeeScreen"), with and into the Corporation:

FIRST: That the name and state of incorporation of EmployeeScreen and the Corporation, which are the constituent entities of the Merger (the "Constituent Entities"), are as follows:

THIRD: That the Corporation shall be the surviving corporation of the Merger (the "Surviving Corporation"). The name of the Surviving Corporation of the Merger shall be Sterling Infosystems, Inc.

FOURTH: Following the effective time of the Merger, the Certificate of Incorporation of the Corporation as currently filed with the Secretary of State of the State of Delaware shall be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: That the executed Agreement of Merger is on file at an office of the Surviving Corporation, the address of which is One State Street, 24th Floor, New York, NY 10004.

SIXTH: That a copy of the Agreement of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of the Constituent Entities.


SEVENTH: That the Merger is to become effective on December 31, 2017 at 11:58 PM Eastern Time.
