**RELEASE OF SECURITY INTEREST IN CERTAIN TRADEMARK**



NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party does hereby release and terminate its Security Interest in only the Released Trademark, and no other trademarks subject to the Security Interest, and discharges, quit claims and relinquishes unto the Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Released Trademark under the Factoring Agreement.
