**INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT**

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the “Assignment”) is entered into as of January 12, 2018 by and between Stavix Seafoods, Inc., a Massachusetts corporation (“**Assignor**”), and Stavix Seafoods LLC, a Massachusetts limited liability company (“**Assignee**”).

WHEREAS, Assignor has adopted, is using and is the owner of all right, title and interest in, to and under the trademark registrations and domain name registrations set forth in Schedule 1 attached hereto and made a part hereof (collectively, the “**Properties**”); and

WHEREAS, in connection with a reorganization of Assignor’s business, Assignor desires to transfer the Properties and associated good will to Assignee, and Assignee desires to acquire such Properties and good will from Assignor; and

WHEREAS, Assignor and Assignee have entered into that certain Contribution Agreement dated as of even date herewith pursuant to which Assignor has agreed to convey, assign and transfer the Properties to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby assigns, conveys, transfers and delivers unto Assignee all of Assignor’s rights, title and interest in and to the Properties, together with (a) the good will of the business symbolized by and associated with the Properties, (b) all applications for registration, registrations, renewals and statements of use thereof, and (c) the right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Properties or the registrations thereof or such associated good will.

AND ASSIGNOR HEREBY appoints each officer or other authorized representative of Assignee as Assignor’s true and lawful attorney-in-fact (“Attorney-in-Fact”), with full power of substitution, for Assignor and in its name, place and stead and on its behalf and for its use and benefit to execute and deliver all documents and instruments in such form and with such substance and to take all actions on behalf of Assignor that such Attorney-in-Fact deems necessary, advisable or appropriate in order to transfer to and vest in Assignee all of the foregoing rights in the Properties and otherwise to effectuate the assignment set forth herein, including without limitation a document conferring upon NTD Patent & Trademark Agency Limited as attorney for the establishment and protection of the BOS’N Mark in China, the necessary Network Solutions, LLC Registrant Name Change Agreement and to correspond with Network Solutions, LLC to authorize transfer of the domain name registrations specified on Schedule 1 and any filings with the U.S. Patent and Trademark Office and the applicable trademark offices and registrars of domain names in any other jurisdiction that may be necessary to reflect Assignee’s title to the Properties.

AND ASSIGNOR HEREBY agrees to cooperate with Assignee and to follow Assignee’s instructions in order to effectuate the transfer of the Properties in a timely manner.

AND ASSIGNOR HEREBY represents that it has the right to convey the entire interest herein assigned, and that it has not executed any agreement in conflict herewith, effective the date first written above.
