The undersigned corporation, pursuant to Title 13.1, Chapter 9, Article 12.2 of the Code of Virginia, hereby executes the following articles of entity conversion and sets forth:

1. The name of the corporation immediately prior to the filing of these articles of entity conversion is "InfoReliance Corporation". The corporation shall convert to a Virginia limited liability company and its name shall be "InfoReliance, LLC."

**ARTICLES OF CORRECTION
OF

The undersigned, on behalf of the limited liability company set forth below, pursuant to §13.1-1011.1 of the Code of Virginia, states as follows:

1. The name of the limited liability company is InfoReliance, LLC.
