**FIRST AMENDMENT TO
TRADEMARK SECURITY AGREEMENT**

THIS FIRST AMENDMENT TO TRADEMARK SECURITY AGREEMENT (this "Amendment"), dated as of July 26, 2017 (the "Effective Date"), is by THE GREELEY COMPANY, LLC, a Delaware limited liability company f/k/a Greeley Healthcare, LLC; hereinafter, the "Grantor"), in favor of THE PRIVATEBANK AND TRUST COMPANY, in its capacity as administrative agent for the Lenders (in such capacity, the "Administrative Agent").

RECITALS

A. Grantor and Administrative Agent have entered into that certain Trademark Security Agreement dated as of August 26, 2016 (as the same may from time to time be amended, modified, supplemented or restated, the "Trademark Security Agreement"), pursuant to which Grantor has granted Administrative Agent, for the benefit of the Lenders, a continuing security interest in and to all of the "Trademark Collateral", as defined in the Trademark Security Agreement.

B. Grantor and Administrative Agent are entering into that certain Amended and Restated Credit Agreement as of the Effective Date.

C. Grantor has obtained an additional ownership interest in certain Trademark Collateral and the parties wish to amend Schedule 1 to include such additional Trademark Collateral.

AGREEMENT

NOW, THEREFORE, the parties agree as follows:

1. Definitions. Capitalized terms used but not defined in this Amendment shall have the meanings given to them in the Trademark Security Agreement.
2. Schedule 1. Schedule 1 attached hereto amends and replaces that certain Schedule 1 which was attached to the Trademark Security Agreement.
3. Affirmation. Except the amendment to Schedule 1, the Trademark Security Agreement and all covenants, terms, conditions, and agreements therein, shall remain in full force and effect, and are hereby ratified and confirmed in all respects by Grantor.
4. Counterparts. This Amendment may be executed in any number of counterparts and all of such counterparts taken together shall be deemed to constitute one and the same instrument.


