RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS this "Release") is made as of January 16, 2018 and granted by Morgan Stanley Senior Funding, Inc., in its capacity as Administrative Agent (in such capacity, the "Agent") pursuant to (i) the Guarantee and Security Agreement dated as of April 30, 2015, among 21st Century Oncology, Inc. (the "Borrower"), 21st Century Oncology Holdings, Inc. (the "Parent"), the subsidiaries of the Borrower from time to time party thereto (each a "Pledgor" and together with the Borrower and the Parent, the "Pledgors"), and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") and (ii) the Grant of Security Interest in Trademark Rights dated as of April 30, 2015, among the Pledgors party thereto and the Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement" and together with the Security Agreement, the "Security Agreements"), in favor of the Pledgors. Capitalized terms used but not otherwise defined herein have the meanings set forth in the Security Agreement.

WHEREAS, pursuant to the terms and conditions of the Security Agreements, the Pledgors granted to the Agent a continuing lien on and security interest in and to all of its right, title and interest in, to and under the Trademarks including those set forth on Schedule I hereto, all goodwill associated with such Trademarks and all Proceeds of any and all of the foregoing (collectively, the "Trademark Collateral");

WHEREAS the Trademark Security Agreement has been recorded with the Assignment Division of the U.S. Patent and Trademark Office on May 1, 2015 at Reel Number 5508, Frame Number 0009;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, re-pledges, reassigns and releases to the Pledgors any and all goodwill, rights, title, interest, liens and security interests in all Trademark Collateral, without warranty or recourse.


