**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“Release”) is made as of the 16th of January, 2018, by CIT BANK, N.A. (“CIT”, formerly known as OneWest Bank N.A. which was formerly known as OneWest Bank, FSB, the “Lender”) pursuant to the Security Agreement (as defined below), in favor of CHICAGO CUSTOM FOODS, LLC, an Illinois limited liability company (“Grantor”).

**W I T N E S S E T H**

WHEREAS, Lender and Grantor are parties to a certain Security Agreement, dated as of June 29, 2012 (the “Security Agreement”), wherein Grantor granted Lender a continuing security interest in and continuing lien upon the trademarks and trademark applications shown on Schedule A attached hereto (the “Trademarks”), for the benefit of the Lender.

WHEREAS, pursuant to the provisions of the Security Agreement, a Notice of Grant of Security Interest in Trademarks was recorded with the U.S. Patent and Trademark Office on July 30, 2012, at Reel 4831 and Frame 0825;

WHEREAS, Grantor has satisfied the terms of the Security Agreement and requests a specific release of the security interest granted and recorded against the Trademarks; and

WHEREAS, the Lender desires to grant to Grantor a specific release of the security interest granted and recorded against each Trademark.

NOW THEREFORE, for good and valuable consideration previously tendered by Grantor, the receipt and sufficiency of which are hereby acknowledged, Lender does hereby:

1. releases and reassigns to the Grantor any and all liens, security interests, right, title and interest of Lender pursuant to the Security Agreement in the Trademarks, together with the goodwill of the business symbolized thereby; and
2. authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

The validity, interpretation and enforcement of this Release of Security Interest in Trademarks shall be governed by the internal laws of the State of New York, but excluding any principles of conflicts of law or other rule of law that would cause the application of the law of any jurisdiction other than the laws of the State of New York, other than Section 5-1401 and 5-1402 of the New York General Obligations law.
