TERMINATION OF SECURITY INTEREST IN TRADEMARKS

January 16, 2018

WHEREAS, CHICAGO BASEBALL HOLDINGS, LLC, a Delaware limited liability company, having an office at 1101 W. Waveland Avenue, Chicago, Illinois 60613 (the “Grantor”) has granted to JPMorgan Chase Bank, N.A., a national banking association, having an office at 270 Park Avenue, New York, New York 10017 (the “Grantee”), a continuing security interest (the “Security Interest”) in the Grantor’s right, title and interest in, to and under:

(i) the “Trademark Collateral” under, and as defined in, that certain Trademark Security Agreement, dated as of October 27, 2009 (which was filed at the United States Patent and Trademark Office on November 18, 2009 and recorded on Reel 4098, Frame 0843),

(ii) the “Trademark Collateral” under, and as defined in, that certain Trademark Security Agreement, dated as of October 27, 2009 (which was filed at the United States Patent and Trademark Office on November 18, 2009 and recorded on Reel 4098, Frame 0883), as assigned to the Grantor pursuant to the Assignment of Trademark Security Agreement, dated as of October 27, 2009 (which was filed at the United States Patent and Trademark Office on November 19, 2009 and recorded on Reel 4099, Frame 0154),

(iii) the “Trademark Collateral” under, and as defined in, that certain Trademark Security Agreement, dated as of December 1, 2014 (which was filed at the United States Patent and Trademark Office on December 15, 2014 and recorded on Reel 5419, Frame 0505), as assigned to the Grantor pursuant to the Assignment of Trademark Security Agreement, dated as of December 1, 2014 (which was filed at the United States Patent and Trademark Office on December 17, 2014 and recorded on Reel 5421, Frame 0060), and

(iv) the “Trademark Collateral” under, and as defined in, that certain Trademark Security Agreement, dated as of April 28, 2017 (which was filed at the United States Patent and Trademark Office on May 15, 2017 and recorded on Reel 6058, Frame 0512), as assigned to the Grantor pursuant to the Assignment of Trademark Security Agreement, dated as of April 28, 2017 (which was filed at the United States Patent and Trademark Office on May 22, 2017 and recorded on Reel 6065, Frame 0113) (clauses (i)-(iv) being collectively referred to herein as the “Collateral”); and

WHEREAS, the Grantee has agreed to terminate the Security Interest.

NOW, THEREFORE, the Grantee, without any recourse, representation or warranty whatsoever, hereby releases, discharges, waives and relinquishes (a) all of its rights, powers, privileges and remedies with respect to the Security Interest and (b) any and all interest that it has in the Collateral, including, without limitation, the trademarks, service marks, trademark registrations and service mark registrations set forth on Exhibit A attached hereto and the goodwill associated therewith. The Grantee agrees that, upon written request of the Grantor (or any successor-in-interest or assignee thereof), and at the Grantor’s sole cost and expense, the Grantee will execute any document, cause to be made any filing or take any other action reasonably necessary or advisable to effectuate the release of interests contemplated herein.
