- (4) All rights to any benefits of prior use of the Marks by ASSIGNOR.

ASSIGNOR hereby covenants, warrants, and represents that it has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith.

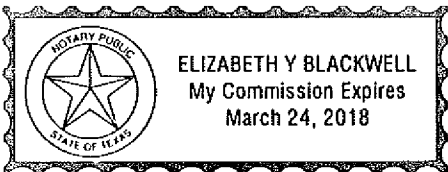
