RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of January 11, 2018 ("Effective Date") by Salus Capital Partners, LLC, a Delaware limited liability company, as administrative agent for itself and other Lenders (the "Administrative Agent") in favor of Robert Talbott, Inc. ("Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Security Agreement (as defined below).

WHEREAS, Grantor, the Administrative Agent and the other parties thereto entered into that certain Security Agreement, dated as of August 20, 2013 (the "Security Agreement") to record the continuing security interest in and to, all of Grantor's rights in and to all Trademarks, including the Trademarks set forth in Schedule A hereto (collectively, the "Trademark Collateral"), and such Security Agreement was recorded with the United States Patent and Trademark Office on September 27, 2013, at Reel 5119, Frame 0082; and


WHEREAS, Grantor requests a specific release of the security interest granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Lenders, terminates and releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Trademark Collateral, together with the goodwill of the business symbolized thereby. Administrative Agent shall, at Grantor's expense, take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), as may be necessary or as may be reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
