

RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE, dated as of December 16, 1997 (this "Release"), is made by Bank of America National Trust and Savings Association (successor by merger to Bank of America Illinois, which was formerly known as Continental Bank N.A.), acting in its capacity as administrative agent (in such capacity, the "Administrative Agent") for each of the banks (the "Banks") party to the Second Restated Secured Credit Agreement, dated as of February 25, 1997 (the "Credit Agreement"), among Sealy Corporation (the "Borrower"), the Banks, Banque Paribas, as Documentation Agent, NationsBank, N.A., as Syndication Agent, and the Administrative Agent;

WITNESSETH:

WHEREAS, the security for the obligations and liabilities of the Borrower to the Banks under the Credit Agreement includes the United States Registered Trademarks and Trademark Licenses (collectively, the "Trademark Collateral") set forth on Exhibit A hereto;

WHEREAS, a security interest in the Trademark Collateral was granted by The Ohio Mattress Company Licensing and Components Group, a Delaware corporation, to the Administrative Agent, for the benefit of the Administrative Agent and the Banks, pursuant to a certain Security Agreement referred to in the Credit Agreement and the Trademark Security Agreement, dated as of July 25, 1989 (the "Original Trademark Security Agreement"), recorded in the records of the United States Patent and Trademark Office on August 18, 1989 beginning at Reel 0665, Frame 586;

WHEREAS, the Original Trademark Security Agreement was (i) supplemented pursuant to that certain Supplement to Trademark Security Agreement, dated as of November 6, 1991, recorded in the records of the United States Patent and Trademark Office on February 19, 1992 beginning at Reel 0848, Frame 886, (ii) assigned and amended pursuant to that certain Assignment of and Amendment to Trademark Security Agreement, dated as of May 7, 1993, recorded in the records of the United States Patent and Trademark Office on May 10, 1993 beginning at Reel 0978, Frame 125, and (iii) supplemented pursuant to that certain Supplement to Trademark Security Agreement, dated as of May 27, 1994, recorded in the records of the United States Patent and Trademark Office on June 24, 1994 beginning at Reel 1176, Frame 001 (the Original Trademark Security Agreement, as so assigned, amended, and supplemented, being hereinafter referred to as the "Trademark Security Agreement"); and

WHEREAS, the Administrative Agent wishes to release its security interest in the Trademark Collateral as recorded in the records of the United States Patent and Trademark Office at the reels and frames noted above;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent hereby terminates and releases its security interest and releases all of its right, title and interest in all of the Trademark Collateral, as set forth on

Exhibit A hereto, granted, assigned or conveyed to the Administrative Agent, for the benefit of the Administrative Agent and the Banks, pursuant to the Trademark Security Agreement.
