This Deed of Assignment is made on 28 April 2017

between (1) Tenon Limited (Assignor)
and (2) Tenon Clearwood Limited Partnership (Assignee)

Introduction

- A. The Assignor is the owner and proprietor of the Trade Marks and Intellectual Property Rights (as defined herein) in New Zealand.
- B. The parties wish to enter into this Deed to record and effect the assignment of the Trade Marks and Intellectual Property Rights from the Assignor to the Assignee.

It is agreed

1. Definition

1.1 In this Deed unless the context otherwise requires:

Effective Date means the date of this Deed.

Trade Marks means the trade marks listed in the Schedule and any resulting registration of the trade marks.

Intellectual Property Rights means all intellectual property rights residing in the Trade Marks including but not limited to copyright and includes the goodwill of the Assignor's business connected with the Trade Marks.

2. Assignment

2.1 On the Effective Date the Assignor assigns to the Assignee:

- (a) its entire right, title and interest in and to the Trade Marks together with the Intellectual Property Rights; and
- (b) all rights and entitlements of the Assignor to take action and recover any damages or other legal remedies available to the Assignor for any infringement of the Trade Marks or for any breach of the Intellectual Property Rights, whether or not such infringement or breach took place prior to the date of this Deed,

without limiting the Assignor's rights under clause 15 of the Agreement for Sale and Purchase of Business and Assets between the Assignor, Tenon Manufacturing Limited and the Assignee dated 14 February 2017.

3. Execution of documents

3.1 The Assignor will:

- (a) execute all documents and do all acts necessary or convenient to vest the Trade Marks and any Intellectual Property Rights in the Assignee for a period of up to 6 months following the Effective Date; and
- (b) execute all documents and do all acts necessary or convenient to enable enforcement of the Trade Marks and any Intellectual Property Rights.
