**CERTIFICATE OF OWNERSHIP AND MERGER**

Pursuant to Section 253 of the Delaware General Corporation Law (the "DGCL"), KYOCERA SENCO Industrial Tools, Inc., a Delaware corporation (the "Corporation"), does hereby certify to the following information relating to the merger (the "Merger") of the Corporation with and into KYOCERA SENCO Brands, Inc., a Delaware corporation (the "Subsidiary"), with the Subsidiary remaining as the surviving corporation:

1. The Corporation and the Subsidiary were incorporated in Delaware.
2. The Corporation owns all of the outstanding shares of capital stock of the Subsidiary.
3. The Board of Directors of the Corporation, by resolutions duly adopted by unanimous written consent on December 21, 2017 (the "Resolutions"), determined to merge the Corporation with and into the Subsidiary pursuant to Section 253 of the DGCL, with the Subsidiary surviving the Merger.
4. The Board of Directors of the Corporation, by the Resolutions, further resolved to change the name of the Subsidiary to "KYOCERA SENCO Industrial Tools, Inc."
5. Kyocera Corporation, the sole holder of all of the outstanding shares of capital stock of the Corporation (the "Parent"), approved the Merger on December 21, 2017.
6. The Subsidiary shall be the surviving corporation of the Merger.
7. Upon completion of the Merger, the Parent shall receive a number of shares of common stock of the Subsidiary equivalent to the number of shares of common stock of the Subsidiary held by the Corporation immediately prior to the Merger.
8. The Certificate of Incorporation of the Subsidiary, as in effect immediately prior to the Merger, shall be the Certificate of Incorporation of the surviving corporation, except that Article One of the Certificate of Incorporation is hereby amended and restated in its entirety as follows:

"First, The name of the Corporation is KYOCERA SENCO Industrial Tools, Inc."

9. This Certificate of Ownership and Merger and the Merger shall become effective on January 1, 2018 at 12:01 a.m. Eastern time.
