**NOTICE OF RELEASE  
OF SECURITY INTEREST IN U.S. TRADEMARKS**

This **NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS** ("Notice of Release"), effective as of January [18], 2018, is made by **BANK OF AMERICA, N.A.**, successor in interest to Fleet Retail Finance Inc. as agent (the "Agent").

WHEREAS, **BASS PRO INTELLECTUAL PROPERTY, L.L.C.**, formerly known as Bass Pro Trademarks, L.L.C., a Missouri limited liability company, (the "Grantor") and Agent, entered into that certain Trademark and Trademark Applications Agreement dated as of December 30, 1999 (the "TM Agreement") and that certain First Amendment to Trademark and Trademark Applications Security Agreement (the "Amendment", and together with the TM Agreement, the "Security Agreement"), whereby Grantor granted to Agent a continuing security interest (the "Security Interest") in all of its right, title and interest in the TM Collateral (as defined in the Security Agreement), including, without limitation, each trademark registration and application listed on Schedule I attached hereto and incorporated herein by reference (the "Specified Trademark Collateral").

WHEREAS, the TM Agreement and the Amendment were recorded in the records of the U.S. Patent and Trademark Office on January 27, 2000 at Reel/Frame 2022/0196 and on July 16, 2004 at Reel/Frame 2894/0647, respectively.

WHEREAS, the Agent has agreed to release its Security Interest in, and discharge fully its lien on, the Specified Trademark Collateral in accordance with the terms of the Security Agreement, and as herein provided.


NOW, THEREFORE, pursuant to the Security Agreement, and upon the terms set forth in this Notice of Release, the Agent hereby agrees as follows:

1. Release of Security Interest. For valuable consideration, the Agent hereby terminates, discharges and releases all mortgages, liens and Security Interest granted to the Agent in the Specified Trademark Collateral without representation, warranty or recourse of any kind, and any right, title or interest of the Agent in such Specified Trademark Collateral shall hereby cease and become void.
2. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.
3. Governing Law. This Notice of Release shall be governed by, and construed in accordance with, the laws of the State of Massachusetts.
