TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of January 3, 2018 by **SCARBOROUGH FAIR LLC** (the "*Secured Party*"), in favor of **COMMUNICATIONS INTEGRATORS, INC.** ("*Grantor*").

WHEREAS, Grantor executed and delivered a Trademark Security Agreement dated as of January 13, 2004, (as amended, modified or supplemented prior to the date hereof, the "*Trademark Agreement*"; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Trademark Agreement), granting the Secured Party a security interest in and lien on certain trademarks described therein (the "*Trademark Collateral*");

WHEREAS, the Trademark Agreement was recorded with the United States Patent and Trademark Office ("*USPTO*") on January 13, 2004, at Reel 002784, Frame 0633; and

WHEREAS, the Grantor has requested that the Secured Party hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademark Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby:

1. terminates the Trademark Agreement and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under the Trademark Collateral, and all goodwill associated therewith, including, without limitation, the Trademark Collateral identified in Schedule I hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at the Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to the Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
